## **Co-option Eligibility Form**

In order to be eligible for co-option as a Holcot Parish Councillor, you must be a British subject, or a citizen of the Commonwealth or the European Union, and on the 'relevant date' (ie the day on which you are nominated or if there is a poll, the day of the election) 18 years of age or over and additionally able to meet one of the following qualifications set out below. Please tick which applies to you:
	<ul> <li>a) I am registered as a local government elector for the Parish; or</li> <li>b) I have, during the whole of the 12 months preceding the date of my co-option, occupied as owner or tenant, land or other premises in the Parish; or</li> <li>c) My principal or only place of work during those twelve months has been in the Parish; or</li> <li>d) I have, during the whole of the 12 months, resided in the Parish or within 3 miles of it</li> </ul>
2.	<ul> <li>Please note that under Section 80 of the Local Government Act 1972 a person is disqualified from being elected as a Local Councillor or being a member of a Local Council if he/she:</li> <li>a) Holds any paid office or employment of the local council (other than the office of Chairman) or of a joint committee on which the Council is represented; or</li> <li>b) Is a person who has been adjudged bankrupt or has made a composition or arrangement with his/her creditors (but see below); or</li> <li>c) Has within 5 years before the day of election, or since his/her election, been convicted in the UK, Channel Islands or Isle of Man of any offence and has been sentenced to imprisonment (whether suspended or not) for not less than 3 months without the option of a fine; or</li> <li>d) Is otherwise disqualified under Part III of the representation of the People Act 1983 for corrupt or illegal practices.</li> </ul>
This dis i) ii) iii)	qualification for bankruptcy ceases in the following circumstances:  If the bankruptcy is annulled on the grounds that either the person ought not to have been adjudged bankrupt or that his/her debts have been fully discharged;  If the person is discharged with a certificate that the bankruptcy was caused by misfortune without misconduct on his/her part;  If the person is discharged without such a certificate.
